Background Check

The Inspection Service criminal background check is conducted using United States information resources only (e.g., FBI fingerprint check, state and county checks). A criminal background check involves a 5-year inquiry for any location where the individual has resided, worked or gone to school within the United States or its territories. As a result of this limitation, the criminal background checks of individuals who have not resided in the United States or its territories for the preceding 5-years may not be considered complete. Cases, delivers, and collects mail along a prescribed rural route using a vehicle; provides customers on the route with a variety of services.

- 2. Receives and signs for accountable mail.
- 3. Loads mail in vehicle.
- 4. Delivers mail to customers along a prescribed route and on a regular schedule by a vehicle; collects monies and receipts for accountable mail; picks up mail from customers' roadside boxes.
- 5. Sells stamps, stamped paper and money orders; accepts C.O.D., registered, certified, and insured mail and parcel post; furnishes routine information concerning postal matters and provides requested forms to customer.
- 6. Returns mail collected, undeliverable mail, and submits monies and receipts to post office.
- 7. Prepares mail for forwarding amd maintains records of change of address information.
- 8. Prepares a daily trip report and maintains a list of the customers on the route.
- 9. Conducts special surveys when required.
- 10. Maintains an inventory of stamps and stamped paper as needed to provide service to customers on the route.
- 11. Provides for mail security at all times.
